- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of cert Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indication turnover details for the relevant period shall be uploaded with the bid. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted r. The delivery period of quantity shall commence from the last date of original delivery order and in cases when option clause is exercised during the extended delivery period the additional time shall commence from the last of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times C delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration the original delivery period while exercising the option clause. Bidders must comply with these terms.

If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Pric product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty witl Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Seci (PBG).Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer sha the right to get the service / rectification done from alternate sources at the risk and cost of the Seller beside: forfeiture of PBG. Seller shall be liable to re-imberse the cost of such service / rectification to the Buyer.
